



Invitation to Apply for Eligibility and to Bid

1. The **Clark International Airport Corporation**, through the **Corporate Capital Expenditures Budget for CY 2008** intends to apply the sum of **Php. 5,308,981.20** being the Approved Budget for Contract (ABC) to payments under the contract for the **Contracting of Services of 30 Private Security Agency Guards**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulation Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act, and restricted to Filipino citizens/sole proprietorship,

organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5138 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138). Only bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine his responsiveness to the technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.

3. A complete set of Bidding Documents may be purchased by interested bidders from the address below and upon payment of a non-refundable fee in the amount of **Five Thousand Pesos (Php 5,000.00)** commencing **January 23, 2009**. The method of payment will be in the form of cash or manager's check payable to CIAC. The Bidding Documents shall be received personally by the prospective bidder or his authorized representative.
4. All bids must be accompanied by a Bid Security in the form as indicated below. Late Bids shall not be accepted.
